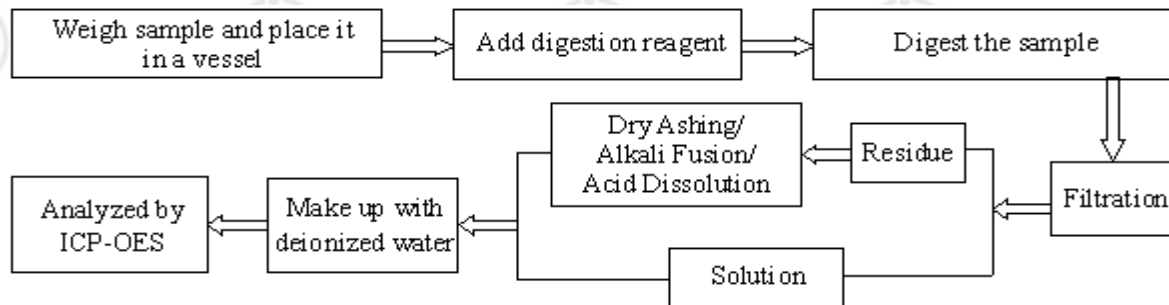

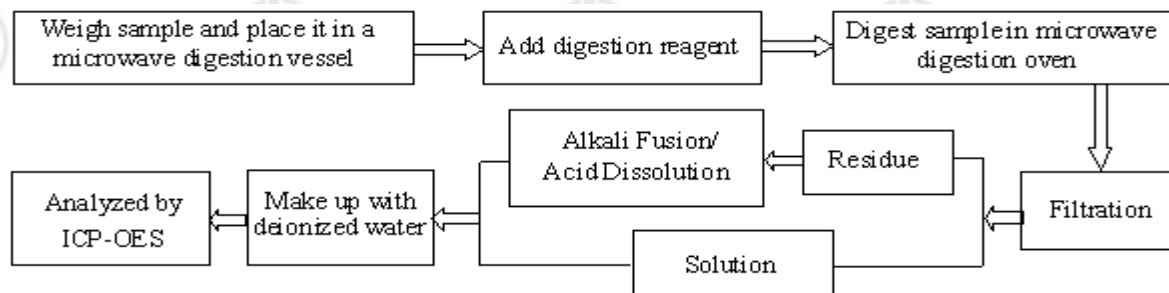

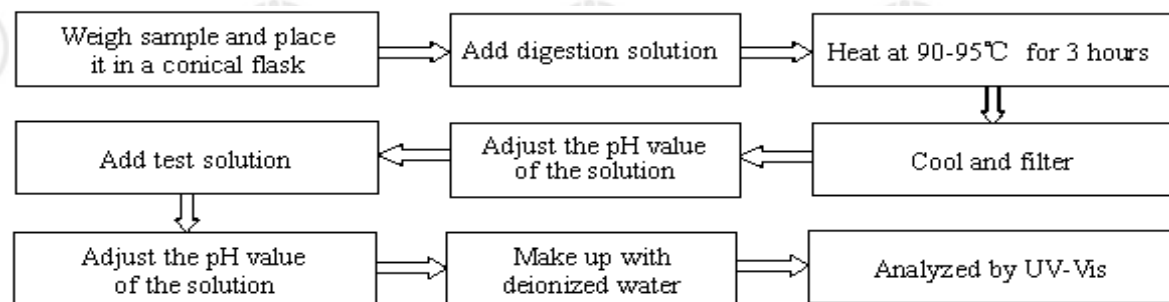
### 1. Lead (Pb), Cadmium (Cd)



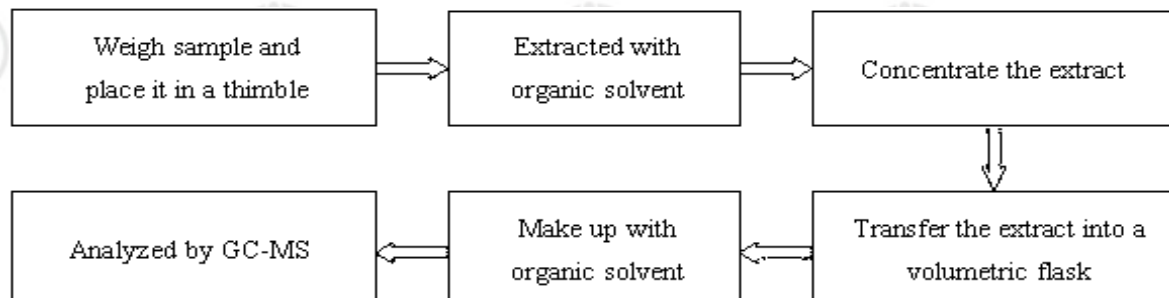
### 2. Mercury (Hg)
